2	Up-Gradation/ Restructure on behalf of " <u>Prescribed Qualification</u> ".	" <u>COMPUTER PERSONNEL</u> " having " <u>Prescribed Qualification</u> " B.A/BCS/ Graduation + three year experience as " <u>COMPUTER PERSONNEL</u> " are eligible for Up-Gradation/ Restructure in BPS-16 with nomenclature "Senior Computer Operator".
